STRATEGY OVERVIEW

What YieldShield Alpha Does

Sells premium

on liquid options for 20+ U.S. ETFs
(SPY, QQQ, GLD, etc.)

Constant hedge

buys protective PUTs on SPY and CALLs on
VIX – insurance against “black swan” events

Capital under control

≤ 60% of account is deployed; remainder is
held as reserve

Income buffer

20% of account is allocated to YieldMax
ETFs with 6 % p.a. yield; additional income
from covered calls

Core idea

Earn option premiums regardless of market
direction while actively hedging capital



WHY THIS IS ATTRACTIVE FOR INVESTORS

Metric	YieldShield Alpha	S&P 500 ETF (SPY)
Cumulative Return (20 months)	+67%	+13%
Target Annual Return	42% ± 10%	~10%
Sharpe Ratio	1.65	-0.02
Sortino Ratio	2.47	-0.03
Max Historical Drawdown	-17.3%	-15.7%

- Outperforms the market in both return and risk-adjusted terms
- Fast recovery: 39 days from maximum drawdown
- Full transparency: account on Interactive Brokers, investors see all trades in real time



HOW WE GENERATE RETURNS

54% - 18% + 6% ≈ 42% annually

(premium - hedge + YieldMax = target return)

Average of 6 option sales per month, ~1.5 % each

18%

Hedging costs ~1,5 % of account monthly (safety prioritized over profit)



YieldMax ETFs offset up to 1/3 of hedge costs and generate dividends

algorithm reduces delta on
VIX spikes



Access to Funds	Investor only; we receive trading rights only (no withdrawals)




